Chennai Metro Rail Limited (CMRL), a Joint Venture of Government of India and Government of Tamil Nadu, is a special purpose vehicle (SPV) entrusted with the responsibility of implementing the Metro Rail Project in the city of Chennai.

CMRL invites applications from qualified and experienced personnel for the appointment of undermentioned posts on deputation / contract basis: -

**a) Joint General Manager / Deputy General Manager (Underground - Design) (01 Post) – Post Code -1**

The candidate should possess a B. E / B. Tech (Civil) graduate from a recognized University / Institute, approved by AICTE / UGC. Possession of M. E / M. Tech degree (Civil / Structural Engineering) is preferable.

The candidate should have minimum post-qualification experience of 15 years for JGM and 13 years for DGM in planning and design of Viaducts, Bridges and Multistorey Buildings. Out of 15 / 13 years of experience, minimum 08 years' experience in Metro Railway projects with Design of Viaduct, Tunnels & Under Ground Stations is essential. Hands on knowledge of various computer applications, relating to the job and well versed with various design software's would be preferred.

The candidates should be familiar with the Standard Indian & Euro Codes and Practices followed in India for Buildings, Bridges, Tunnels and UG stations.

**b) Joint General Manager / Deputy General Manager (Elevated - Design) (02 Post) – Post Code -2**

The candidate should possess a B. E / B. Tech (Civil) graduate from a Govt recognized University / Institute, approved by AICTE / UGC. Possession of M. E / M. Tech degree (Civil / Structural Engineering) is preferable.

The candidate should have minimum post-qualification experience of 15 years for JGM and 13 years for DGM in planning and design of Viaducts, Bridges and Multistorey Buildings. Out of 15 / 13 years of experience, minimum 08 years' experience in Metro Railway projects with Design of Viaduct, Elevated Stations is essential. Hands on knowledge of various computer applications, relating to the job and well versed with various design software's would be preferred.

The candidates should be familiar with the Standard Indian & Euro Codes and Practices followed in India for Buildings, Bridges, Elevated stations.

**c) Joint General Manager / Deputy General Manager (PIMS) (01 Post) – Post Code -3**

The candidate should possess a B. E / B. Tech (Civil) graduate from a Govt. recognized Institute / University approved by AICTE/UGC. Post graduation in a relevant field is desirable.

The candidate should have minimum 15 years of post-qualification executive experience for the Joint General Manager level and 13 years of post-qualification experience for Deputy General Manager level respectively in project management and out of which minimum 7 years of experience in ERP, SAP and other Project Management software's is required.

- i. Candidates should have experience in managing the team of software developers, Technical Team, GC, Contractor and DDC for all the disciplines.
- ii. Candidates should be able to manage the team meetings and provide periodical update of physical and financial Progress in Designated Portals and should have significant familiarity with other software's likes MS Excel, MS Word, PowerPoint, CAD etc.

**d) Deputy General Manager (Electrical & Mechanical) (01 Post) – Post Code -4**

The candidate should be an Officer in Group 'A' / 'B' service from Indian Railways as per the following criteria: -

**i. Scale of pay for deputation post:**

- a) The deputationist shall have the option either to draw pay being drawn in the parent organization with deputation allowance and project allowance at 10% of Basic Pay each.
- (or)
- b) To draw equivalent cadre IDA, pay scale in CMRL with IDA, HRA and Cafeteria Allowance (20% of Basic Pay).

**ii. Maximum Age:**

- a) 45yrs (Age will be relaxed for deserving candidates)

**iii. Tenure of deputation:**

- a) Initial period of deputation will be for a period of 3 years, which may be extendable up to 5 years.

**iv. Qualification & Experience:**

- a) Must be a B.E / B. Tech (ECE/EEE/Mech) graduate from a recognized Institute / University, approved by AICTE / UGC.
- b) For DGM post – Should be in JAG grade in Group (A) with minimum 06 years or Group B with minimum 10 years of experience.
- c) The incumbent should have experience in the field of MEP / E&M: HT / LT Electrical Power Supply Systems, UPS Systems, Earthing Systems, Lightning Arrestor, Fire deduction, Fire Alarm, Fire Protection System, Plumbing Systems, BMS / SCADA Systems of their BIM / Design review, development, interface management, procurement, installation, testing and commissioning in Railway projects / Metro Rail projects or any large infrastructure projects.

**e) Deputy Manager (Transport Planning) (01 Post) – Post Code -5**

The candidate should possess a M. E / M. Tech (Transportation Planning / Transportation Engineering / Traffic Engineering / Urban Engineering) from a recognized Institute / University, approved by AICTE /UGC. The candidate should have minimum post-qualification experience of 4 years in execution of large Transportation infrastructure projects and involved in city level Transportation studies such as CCTS, CMP, Feasibility, DPR, etc.

**Duties and Responsibilities: -**

- i. Transport Planning for Metro Rail Operations.
- ii. Overall Integrated Planning with respect to city mass rapid transit system/Public Transport system.
- iii. Dealing with Multi Modal Integration Transport system issues & solutions.
- iv. Preparation of Station accessibility plan (People/Vehicle).

- v. Periodical review of metro ridership data and metro passenger travel pattern.
- vi. Periodical review of Metro operations plan with respect to Passenger demand.
- vii. To prepare Strategy on Feeder Bus operations.
- viii. To Monitor Fare box revenue.
- ix. To Coordinate with State/Central Government agencies regarding Transport Planning Projects and issues.
- x. CUMTA coordination Works.
- xi. To review and monitoring of various Transport Planning related consultancy assignments such as Feasibility study, DPR, Techno economic feasibility, etc.

**f) Deputy Manager / Assistant Manager (QA/QC) - (01 Post) – Post Code -6**

The candidate should possess a BE / B. Tech in Civil engineering from a Govt. recognized University / Institute, approved by AICTE / UGC.

The candidate should have minimum post-qualification experience of 04 years for DM and 02 years for AM in Quality Assurance / Quality Control (QA / QC) in Metro Rail / Large Infrastructure / Construction projects. Possession of additional certification / Diploma in Quality will be an added advantage.

**2) Selection process:**

The selection methodology comprises of two - stage process, interview followed by a medical examination. The selection process will judge the candidate on different facets like knowledge, skills, comprehension, attitude, aptitude, and physical fitness.

**Medical Examination:**

Expenses for the first-time medical examination of the candidate will be borne by CMRL. However, in case a candidate seeks extension for joining, then the second time medical examination expenditure will be borne by the candidate. To & fro travel expenses for the medical test shall be borne by the candidate. The candidate who fails the prescribed medical test will not be given any alternative employment and the decision of CMRL is final on this issue.

**3) Character & Antecedents:**

The success in the above stated selection process does not confer any right to appointment unless CMRL is satisfied after such an inquiry, as may be considered necessary, that the candidate's character and antecedents is suitable in all respects for appointment to the service.

**4) Concessions & Relaxations:**

- a. The age limit prescribed shall be increased by five years in respect of candidates belonging to Scheduled Castes or Scheduled Caste (Arunthathiyars) or Scheduled Tribes and two years in respect of candidates belonging to Most Backward Classes/ Denotified Communities, Backward Classes (other than Muslim) or Backward Classes (Muslim).
- b. A Differently Abled Person shall be eligible for an age concession up to ten years over and above the age limits prescribed for the notified post by direct recruitment only, provided the applicant is otherwise fully suitable and the disability is not such as would render him incapable of efficiently discharging the duties w.r.t post for which the candidate is selected.

- c. The upper age for Ex-Servicemen will be prescribed age limit plus the length of service in armed forces plus 03 years.

**5) Payment of application fee (Non-refundable fee):**

- a. **6) General Conditions:**

- a. Only Indian Nationals need to apply.
- b. Age, Qualification & experience stipulated above should be as on **04-09-2024**. The candidates before applying are advised to ensure that they fulfill the eligibility criteria and other requirements mentioned and that the particulars furnished by them are correct in all aspects. In case, if it is detected at any stage of recruitment process that the candidate does not fulfill the eligibility criteria and / or does not comply with other requirements of this advertisement and / or the candidate has furnished any incorrect or false information or has suppressed any material fact, the candidature is liable to be rejected. If any of the above shortcomings is / are detected even after appointment; the services will be terminated without any notice.
- c. The contract period for contract type of appointment is initially for a period of 2 years and the same will be extended for further period subject to the requirement and performance of the candidates as per the existing terms and conditions on mutual consent.
- d. In order to regulate the number of candidates to be called for interview, if so required, the management reserves the right to raise the minimum eligibility standards/criteria.

**Step 2** - A registration link will be sent to the candidate's registered email id. Therefore, candidates are required to click the verify button to authenticate their email id. Upon verifying, the user will be redirected to the CMRL career page to log in and apply.

**Step 3** – Candidates are required to fill all details in each section and make sure to upload the requisite documents as per the notification, wherever applicable, in order to authenticate the details mentioned in the application form.

- c. Scrutiny of applications for short listing of candidates will be solely based on documents / certificates uploaded by the candidates at the time of registration / submission of application through ONLINE. In case, if it is detected at any stage of recruitment process that the candidate does not fulfill the eligibility criteria and / or does not comply with other
